



**W**elcome to South East Queensland's premier horticultural trade day, **BRISBANE TRADE DAY**.

Experience a morning with various horticultural traders offering exceptional quality and service. This is a **TRADE ONLY** enterprise available to Horticultural businesses.

There are approximately 30 standholders each Trade Day with buyers each month including retail nurseries, hardware stores, landscapers, florists and allied traders. There are currently over 600 buyers registered who can attend Trade Days and approximately 100 attend each month.

The charge for Permanent Standholders in 2020 equates to \$165 per month, incl. GST  
Block 1 fee for 2020 is \$990 incl. GST which covers January, February, March, April, May & June  
Block 2 fee for 2020 is \$660 incl. GST which covers September, October, November & December

The charge for Casual Standholders in 2020 is \$200 per month, incl. GST for NGI members *or* \$300 per month incl. GST for non-members (Allied Trade ONLY)

If you trial as a casual standholder and then confirm as a permanent standholder, any amount paid for your trial will be deducted from the amount payable for a permanent block.

A hot breakfast is available for all in attendance and free parking is provided. Promotional flyers are available for monthly Trade Days to remind Standholders and Buyers of Trade Day details.

Standholders come from Brisbane, Regional Queensland and New South Wales. There are buyers registered from Victoria, Northern Territory, Western Australia and South Australia with regular buyers from Queensland, and New South Wales.

Brisbane Trade Day is held monthly and will be at The Marquee, Brisbane Showgrounds from January – June 2020. In July, trade day will head south to the Gold Coast and then north to Nambour in August and return to Brisbane Showgrounds for trade days from September – December 2020.

## **NGIQ TRADE DAY TERMS & CONDITIONS**

- Permanent standholders are expected to attend all Trade Days. Notification of non-attendance must be given.
- Standholder entry must be prior to 6.30am.
- Sales transacted from 6.45am must be with NGIQ members ONLY. All other sales to be transacted from 7.00am.
- Stock must remain on stands until 7.30am for NGIQ members & 7.45am for all other buyers.
- Standholders must maintain their stand area until conclusion of Trade Day.
- Standholders are expected to assist buyers in the removal of stock.
- Standholders are required to enforce these terms to ensure successful Trade Days.
- Greenlife standholders must be a member of NGIQ or reciprocal state NGI Association
- Business name must be prominently displayed at all times.
- Pricing must be provided for all stock lines for the convenience of customers.
- All products are to be correctly labelled.
- Standholder applications remain subject to availability and are accepted on the uniqueness of lines offered; quality of stock; availability to attend regularly and/or at short notice
